The results of experiments using pigments of this type indicate no toxicologically relevant properties. Since the substance is poorly absorbed, no systemic effects are to be anticipated.

Inhalation of the dusts should be avoided as even inert dusts may impair respiratory organ function.

The individual test results were as follows:

Skin tolerance: no irritant effect.

**Eye irritation test:** no irritant effect;

Sensitization test: no sensitizing potential.

LD50 (oral, rat): not determinable; all animals still alive after 15000mg/kg.
